Good morning on Oct. 19, 2021 at aprox. 7:50 AM our Housekeeper saw a man walking around the dumpster area. He asked if he needed any help and the man introduced himself as Dr. Bartlet and wanted to know if we had some plastic bags. [REDACTED] said "no, but we can go to the Storeroom and see if we can get you some help." Oscar proceeded to bring him to the Storeroom and with [REDACTED] present the man asked me if we had the plastic bags that go over equipment or did we dump them all in the trash. I responded no we do not keep them here and who was he. He said "oh I'm Dr. Bartlet and I would like to see where the bags are kept." I said ok and guided him up to RT where he could talk to Renato. After I brought him to [REDACTED] I left.

It is my fault that I let him through without a badge but I encounter providers all the time who do not have a badge and just need to get to the OR, Cath Lab, etc. so they can get it. [REDACTED] had no idea who the man was either and he thought he just needed some help. He definitely came through the back dock area.

Today around 8:30am around the Back Dock area, I was working with my trash truck/dump truck. I saw an Employee "I ask him who he was" "he said he was a Doctor I could not understand him". He was looking around the trash area he said he was looking for "COVID BAGS" he said he wanted to know where they were, I said I would take you to Harvey in the supply room manager, he said ok, I took him to Harvey, he started asking Harvey why are they putting bags on people with COVID. I left him with Harvey because he's a manager. I saw him walk out the back Dock and leave the building. [REDACTED] came out to see where he was but he had left.

Good morning,

At approximately 8:00 am I was in my office. I heard voices. It was [REDACTED] with Central Supply and older gentleman. He introduced himself as Dr. Bartlett. I was in shock. [REDACTED] told him that the bags used were the ones I ordered for equipment.

Dr Bartlett asked: "Are these the bags you use for patients?" There were vents and an Airvo in the hallway bagged, ready for patient use.

I told him we were modifying our process. I did ask what I could help him with, no reply.

I turned around to look for [REDACTED] who had stepped away. I heard a camera click and his phone was out.

He then excused himself stating he was in a hurry. He did not have a mask (nor did I as it all happened so fast), any identifier, or a visitor wristband. He went down the back elevator.

I met with [REDACTED] he stated [REDACTED] (housekeeper) had escorted Dr Bartlett to central supply from the back dock.

I wish I could have stopped the picture, but I was in such shock that he was up here.

Dr. Bartlett then went to the respiratory unit taking pictures of the equipment that was covered with clear coverings located on 2 west. this act was not authorized by the hospital at the time.
