
# Revenue Replacement

"This provision allows recipients to use payments from the SLFRF funds to avoid cuts to government services and, thus, enables state and local governments to continue to provide valuable services and ensures that fiscal austerity measures do not hamper the broader economic recovery." – Interim Final Rule

"For example, transportation infrastructure projects are generally ineligible as a response to the public health and negative economic impacts of the pandemic; however, a recipient could fund these projects as a government service." - Interim Final Rule



## Public Safety Communications Updated CAD System

The current system is outdated and experiences down time, causing delays in dispatching units.

The new system would be a pre-paid 5-year contract that includes installation, yearly maintenance, and program interfaces. Total cost of \$1,422,410.

The current CAD system yearly maintenance fee is \$177,944. Yearly maintenance for the new system is \$68,563 per year.

# Fire Department

- Hiring and relocation incentives for recruitment and retention.
- Yearly cancer screening for OFR employees.

- Verkada camera system for all stations except Firehouses 6 & 9.
- Vehicle Needs:
  - Three new engines and one new ladder truck.
  - Wildland brush truck.
  - Second Squad vehicle.
  - Replace Tender 8 (apparatus).
  - Replace HazMat 5 (apparatus).
- Stryker Cots and Power Loads for the New Ambulances.
- Cardiac monitor Replacement.
- New training facility at OFR drill field. Training buildings, one large classroom, and two breakout classrooms.
- Replace firehouses 2 & 3 along with apparatus and equipment.
- Build Firehouse 10, 11 & 12 along with apparatus and equipment.





# Police Department

#### Demolition of the 2-story parking lot located at 201 N Grant.- \$276,890

This parking lot needs a significant amount of repairs, Management has indicated that they prefer to remove the structure

#### Lobby Public Restrooms.- \$208,139

The public men's and women's restrooms have not been updated since the building was constructed in 1982. The remodel will bring the restrooms into compliance with ADA

#### Modernization of 2 existing elevators.-\$313,669

The elevators have not been updated since the building was constructed in 1982. An update to the elevators will increase the efficiency of workers and will allow easier access for local citizens.

## Timeline for use of SLFRF funds

Recipient may only use funds to cover costs incurred during the period beginning March 3, 2021, and ending December 31,2024. <u>Recipients</u> <u>must expend all funds by December 31, 2026</u>

Any funds not obligated or expended for eligible uses by the timelines above must be returned to Treasury, including any unobligated or unexpended funds that have been provided to subrecipients and contractors as part of the award closeout process pursuant to 2 C.F.R. 200.344(d).



## Restrictions on the uses of these funds

Funds allocated to states cannot be used to directly or indirectly to offset tax reductions or delay a tax or tax increase.

Funds cannot be deposited into any pension fund.
