## Narrative by Pietropollo, Bobby

On 02/22/2024 at 1206 hours, I was dispatched to the Ector County Elections Administration located at 1010 E. 8TH St. in reference to a Disturbance.

Upon arrival the involved parties were identified as Carmen Estela Wilhite and Donna Janell Kelm.

Upon investigation I was advised that both individuals were campaigning to potential voters when an argument occurred over Carmen claiming to be the true Republican representatives and claiming Donna was for the Democratic party. During the argument Carmen claimed that Donna had aggressively grabbed her arm at which point Carmen threw her arm back in an attempt to get Donna to stop touching her, while telling her "not to touch her". Upon speaking with Donna she stated that she gently touched Carmen's arm in a non-aggressive way so that she can simply request Carmen to not accuse her to being a Democrat. She stated when Carmen flung her arm back she had grabbed Donna by the back of her hair and yanked on it, causing her pain and believing she may have pulled some hair out of her head.

I did speak to a Linda Hall who stated that she did see the incident. She stated that Donna did gently touch Carmen on the arm before Carmen pulled away. Linda states that Donna did not appear to be threatening or aggressive towards Carmen.

Carmen stated that she does want to file charges and both parties were advised to stay separated and avoid contact with each other. Case numbers were provided to both parties and Carmen was advised to contact Municipal Court to continue with filing charges against Donna.

Neither parties had visible injuries nor request for medics. No photos were taken.

On 02/22/2024 at approx. 1215 hours, I responded to 1010 E 8th (Ector County Annex) in reference to assist Cpl. B. Pietropollo on a Disturbance.

Before my arrival, Cpl. Pietropollo advised he was Code 4. As I arrived on scene, I asked Cpl. Pietropollo what all he needed for his investigation and he stated he need one party involved identified. I then spoke to that person who identified as Carmen Wilhite W/H/F (DOB: [REDACTED]). Carmen began stating she and other candidates were on scene of the listed location informing customers who they were and which candidate party (the listed location was a voting poll). Carmen stated on subject approached her asking for Republican candidates to which she provided a flyer to the subject stating she was part of the Republican party. Carmen advised at that time, the other person involved in the investigation, being Donna Kelm W/N/F (DOB: [REDACTED]) who Cpl. Pietropollo was speaking too, approached her and the subject and handed the subject a flyer of her own. Carmen advised to the subject that there were no Democratic party members with her to which Donna began yelling "she was not a Democrat" to Carmen. Carmen advised she did not call Donna a Democrat but Donna reacted by grabbing her arm. Carmen advised she then threw her arm back to get Donna to let go of her and yelled at Donna stating "don't grab me." Carmen continued advising that Donna continued to approach her and she continuously told Donna to "not touch her." Carmen stated nothing happened afterwards.

She was fully identified and the information was provided to Cpl. Pietropollo. Carmen was given a PD-139 along with the case number for her records. I was no longer needed and went back into service.
